Diamond Drilling Resumes at Brandy Hill South

Key Highlights

- Diamond drilling resumes at Brandy Hill South
- An alternative approach road has allowed access to the drill site

Recharge Metals Limited (ASX: REC, Recharge or the **Company**) is pleased to announce that drilling operations at the Brandy Hill South Project has resumed. The Project is located within the Archaean Gullewa Greenstone Belt within the Murchison Province, Yilgarn Craton.

Drilling was suspended on the 5th of April because rain events caused surface wetness and pooling of water in certain areas along tracks at Mellenbye Station preventing access to the drilling area. This resulted in drill hole BHRCD018, the second of three diamond holes, not being accessible. Drilling commenced on BHRCD018 on 19 March and the hole is at a current depth of 210m.

Next Steps at Brandy Hill South

- Completion of diamond tails on drillholes BHRCD018 and BHRCD023
- Completion of downhole electromagnetic (DHEM) surveying, and
- Detailed logging and analysis of all drill core before being submitted to the laboratory for analysis


