Suspension and New Opportunities Update

The Company's securities remained suspended throughout the Quarter, pending the Company commencing its next stage of activities.

During the Quarter, the Board continued to progress towards finalising details of the Company's proposed future direction, and the Company hopes to be in a position to update the market shortly in this regard.

Operational Expenditure and Payments to Related Parties

As noted in its Appendix 4C, during the Quarter the Company expended a gross total of \$121,000 on the operations of the Company, for administrative and corporate costs. Payments to related parties and their associates as detailed in Section 6 of the Appendix 4C are payments for director fees (\$38,000) and corporate services, accounting, and company secretarial fees (\$23,000).
