

Changes to Board of Veris Limited

- Resignation of Mr Adam Lamond as Non-Executive Director of Veris Ltd, completing 11 years of service to the Group, having founded and overseen the ASX listing of OTOC Ltd, the forerunner of Veris Ltd
- Dr Michael Shirley, CEO of Veris Australia Pty Ltd, to be appointed Managing Director of Veris Ltd

Veris Limited (VRS:ASX) ("Veris") advises the following changes to the composition of its Board of Directors.

After 11 years serving as Managing Director and a Non-Executive Director of Veris Limited and its forerunner OTOC Limited, Mr Adam Lamond has determined that now is an appropriate time to resign as a Non-Executive Director as of 1 June 2022.

Mr Lamond founded Ocean to Outback Electrical (OTOE) in 2003 and was pivotal in the ASX listing of Ocean to Outback Contracting (OTOC) Limited in 2011, the forerunner to Veris Limited. He served as Chief Executive Officer, and later as Executive Director - Business Development of OTOC, after which time he was appointed Managing Director of the newly branded Veris Limited in 2017. In 2020 Mr Lamond transitioned to the Board of Veris as a Non-Executive Director. Over his time on the Veris Board, Mr Lamond also played an active role in the formation and growth of the Aqura Technologies business, culminating in the realisation of significant value for the Veris Group via the recent divestment of Aqura in early 2022.

The CEO of Veris Australia Pty Ltd, Dr Michael Shirley is to be appointed as Managing Director of Veris Limited, and will join the Board of Veris Ltd as at 1 June 2022. Dr Shirley will retain his role as Chief Executive Officer of Veris Australia.

"On behalf of the Board, I'd like to thank Adam for his significant contribution to the development of Veris as the leading digital and spatial services provider in Australia.

"Adam's vision and contribution to the development of Veris' national platform has been immense over a sustained period of time. After founding what was the forerunner to Veris, he has served the business in senior executive positions and most recently as Non-Executive Director on the Board.

"Adam has made the decision to retire from the Board and we wish him all our best for his future endeavours. The appointment of Dr Michael Shirley as Managing Director of Veris Ltd will ensure the continued focus on the delivery of our strong growth outlook.
