### Notices of change of interests of substantial holder

- 1. I refer to:
  - (a) the Declaration of Unacceptable Consequences made by the Takeovers Panel in respect of the affairs of DRA Global Limited (DRA), dated 9 May 2022 (Declaration); and
  - (b) the orders made by the Takeovers Panel in respect of the abovementioned matter, dated 16 May 2022 (**Orders**).
- 2. The Takeovers Panel considered in its Declaration that, amongst other things:
  - (a) during January and February 2022, Messrs Alistair Hodgkinson, Darren Naylor and James Smith (together referred to as the **Associates**) and myself, came together to discuss and plan operational changes to DRA, including changes to the management and composition of the DRA board;
  - (b) by no later than 17 February 2022, the Associates and myself were associated for the purpose of controlling or influencing the composition of DRA's board and the conduct of DRA's affairs and as a result of this association, the voting power of each of the Associates and myself increased to approximately 11.27%;
  - (c) the Associates and each shareholder who provided an undertaking as to voting (the Other Associated Shareholders) were associated for the purposes of controlling or influencing the composition of DRA's board and the Associates acquired a relevant interest in the shares of each Other Associated Shareholder; and
  - (d) as a result of the association between myself and the Associates, my voting power also increased as a result of the voting undertakings provided by the Other Associated Shareholders.
- 3. The Associates have each subsequently confirmed that they are of the view that they are no longer associated with each other in relation to DRA.
- 4. In accordance with the Orders, I enclose:
  - (a) Firstly, an ASIC Form 604 "Notice of change of interests of substantial holder", disclosing the existence and nature of my association with each of the other Associates and other information required by an ASIC Form 604. I confirm that:
    - (i) there are no documents setting out the terms of any relevant agreement that contributed to the situation giving rise to the need for disclosure; and

- (ii) no other transactions were undertaken during the period covered by the notice.
- (b) Secondly, an ASIC Form 604 "Notice of change of interests", disclosing how and when the association with each of the other Associates ceased and other information required by an ASIC Form 604. I confirm that there are no documents evidencing the ceasing of the association.
- 5. During the Takeovers Panel matter, the structure of my shareholding in DRA was also finally confirmed, following a reorganisation of my financial interests which commenced in mid-2021. The ASIC Form 604s reflect the fact that my relevant interest is now held through Anchor Capital as the registered holder.

Mr Dowding's association with the Associate Group ceased with effect from 22 February 2022 as he has not since that date engaged in any communications or actions alongside Messrs Hodgkinson, Naylor and Smith for the purposes of controlling or influencing the composition of DRA's board and the conduct of DRA's affairs.  Accordingly, with effect from 22 February 2022, Mr Dowding's association with the Associate Group ceased and the Substantial Holder's voting power no longer included any shares held by the Associate Group or the Undertaking Signatories.
