## CONVERSION OF SECURITIES

**Brisbane, Australia and Minneapolis, USA.** Anteris Technologies Ltd (ASX: AVR; **Anteris or the Company**) announces that in accordance with the Convertible Security and Share Purchase Agreement dated 6 January 2021 (**Agreement**) as amended between Anteris Technologies Ltd and Mercer Street Global Opportunity Fund, LLC (**Investor**), the Investor has provided notice to convert its second tranche of convertible notes with a face value of \$1,080,000 into ordinary shares. This investment in the Company foregoes the requirement for the Company to repay this amount.

In accordance with the Agreement, the conversion price is 90% of the five-day VWAP of the Shares up to the issue of the conversion notice being \$15.09. This compares to a closing price of \$3.88 on the date of announcing the Mercer funding package on 6 January 2021.
