CLEANSING NOTICE – ISSUE OF SHARES

- 1. The Company has today issued:
 - (a) 66,000,000 fully paid ordinary shares to unrelated qualified, sophisticated and professional investors, at an issue price of \$0.038 per share, to raise \$2,508,000 (before costs) in proceeds.
 - i. 34,000,835 shares were issued under the Company's available Listing Rule 7.1 placement capacity.
 - ii. 31,999,165 shares were issued under the Company's available Listing Rule 7.1A placement capacity.
- 2. The shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
- 3. As at the date of this notice:
 - (a) the Company has complied with the provisions of Chapter 2M of the Corporations Act as they apply to the Company;
 - (b) the Company has complied with section 674 of the Corporations Act; and
