# Development of Cokal's BBM Coking Coal Mine Continues. Initial Coal Sales Forecast for September 2022

Cokal Limited (**Cokal**) (ASX: **CKA**) is pleased to provide the following update on the Bumi Barito Mineral (**BBM**) coking coal mine (Cokal 60%). Development continues to advance rapidly, and first coal sales remain on-track for September 2022.

This ASX Announcement supplements Cokal's ASX Announcements of 3 June and 8 June 2022 and provides the following additional updates in regards to development activities:

## **Batu Tuhup Jetty**

The initial operations and movement of coal from Krajan will be transshipped into larger barges using a floating crane placed at the Batu Tuhup Jetty.

This set-up will facilitate initial shipments of coal, whilst the permanent infrastructure at the Batu Tuhup Jetty is completed. Permanent facilities will allow for higher-capacity and will receive coal from Cokal's Mohing Haul Road.

Importantly, Cokal has achieved the following milestones in relation to the development of Batu Tuhup Jetty:

- Land clearance works are completed at Batu Tuhup Jetty.
- Land cut & fill works are ongoing.
- Permanent jetty infrastructure development tender to be released in this week.
