


## **EXPLORATION UPDATE**

# **Halls Creek Project**

Cazaly Resources Limited (ASX: CAZ, "Cazaly" or "the Company") is pleased to announce RC drilling has commenced on priority drill targets at the Halls Creek Project located 25km southwest of Halls Creek in the East Kimberley Region of Western Australia.

The drilling at **Moses Rock** will test EM conductor targeting another massive sulphide deposit. Moses Rock is located 5km to the southwest of the Mount Angelo North Cu-Zn-Ag Resource (Figure 1) with significant intercepts including 64m @ 2.72% Cu & 1.13% Zn (\*)





Drilling will also be conducted at the **Bommie Prospect** located 2.5km southwest of Mount Angelo North is interpreted as a large low grade porphyry copper system with significant drill intercepts including 170m @ 0.4% Cu.

Cazaly's Managing Director Tara French commented "It is a great feeling to get back on the ground at Halls Creek to drill our priority targets at Moses Rock and the Bommie Prospect. Now we look forward to completing this program and receiving assay results to plan the next phase of work at Halls Creek."
