
# Development of Sandfire's Motheo Copper Mine in Botswana:

- Proceeding on time with first production scheduled from the June 2023 Quarter
- Construction activities are continuing with approximately 1,600 personnel on site and over 6,000m³ of concrete poured to date

Sandfire intends to fund the development of the Motheo Copper Mine through a combination of cash and project debt:


- Selection of syndicate international banks for a US\$160M debt facility complete and finalisation of terms well advanced
- Facility based on initial Base Case 3.2Mtpa development pending finalisation and review of the 5.2Mtpa Feasibility Study expected during the September 2022 Quarter

Each intake of the YDP occurs on a 6-monthly basis and offers the opportunity to work within exploration, safety health & environment (SHE), or procurement for a 12-month period, with the potential for growth into a permanent opportunity with Sandfire.

The program is aimed at providing individuals a tailored development pathway, supporting skill development and future career opportunities.














#### **Motheo Mine Village**
