
ISSUE OF SHARES AND CLEANSING STATEMENT

The Board of Green Technology Metals Limited (ASX:GT1) (the **Company**) hereby provides notice to the ASX for the purposes of section 708A(5)(e) of the Corporations Act 2001 (Cth).

The Company refers to its announcement on 28 April 2022 regarding the successful share placement to raise \$55 million (before costs). The Company continues to progress drilling at Seymour as well as progressing its feasibility study at Seymour. As at the date of this notice, the Company is not in the possession of any material assay results but is expecting further assay information to be received over the coming weeks.
