## CLEANSING NOTICE

EMVision Medical Devices Limited (ASX: EMV) (“**EMVision**” or the “**Company**”) confirms that it has issued 200,000 fully paid ordinary shares (Shares) pursuant to the exercise of 200,000 unlisted Series B options with a \$0.57 exercise price and 1 July 2022 expiry date. An Appendix 2A regarding the issue of these Shares has also been announced today.

### **Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Cth) (“Act”)**

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the Shares noted in the Appendix 2A will fall within the exemption in section 708A(5) of the Act.
