# ***Completion of Restructuring and Consolidation Exercise***

Reference is made to Fatfish Group Ltd's ("**FFG**" or the "**Company**") announcement on 3 March 2022 regarding the restructuring and consolidation of FFG's investments in fintech businesses under ASEAN Fintech Group ("**AFG**").

FFG is pleased to announce that the restructuring and consolidation exercise of AFG has been completed. Following the completion of the restructuring and consolidation exercise, AFG has increased its stake in:

- Singapore licensed online financing platform, Smartfunding Pte Ltd, from 40% to 92.4%.
- Malaysian based online insurance platform, Fatberry Sdn Bhd, from 11.4% to 62.5%.

FFG now holds approximately 65.9% direct stake in AFG. In addition, FFG also holds an indirect 19.6% stake in AFG via its Swedish listed subsidiary, Abelco Investment Group AB ("**Abelco**").

This announcement has been authorised by the Board of Directors of FFG.
