Cobre Limited - Commencement of Advanced Exploration Drilling at the Kalahari Copper Belt in Botswana

Metal Tiger plc (AIM: MTR, ASX: MTR), the AIM and ASX listed investor in natural resource opportunities, is pleased to note that Cobre Limited ("Cobre") has announced the commencement of the next stage of drilling at Kalahari Metals Limited's ("KML") Ngami Copper Project.
