NOTICE UNDER SECTION 708A(5)(E) OF THE CORPORATIONS ACT 2001 - CLEANSING STATEMENT

De Grey Mining Limited (ASX: DEG, De Grey or Company) wishes to confirm the issue of the following fully paid ordinary shares:

- on 4 July 2022, 450,454 fully paid ordinary shares on exercise of 450,454 zero priced unlisted options;
