PERFORMANCE RIGHTS EXERCISE

Tombador Iron Limited (ASX:T11) (T11 or the **Company**) advises that, in accordance with the terms of the Company's Performance Rights Plan (**Plan**), which was approved at the Company's Extraordinary General Meeting on 31 August 2020, 2,375,000 rights have been exercised into an equivalent number of fully paid ordinary shares (**shares**), and 750,000 performance rights have been exercised into an equivalent number of shares to be held in escrow until 6 October 2022.

Following today's conversion, 25,125,000 Performance Rights remain on issue under the Plan, as follows:

- 4,000,000 Milestone A rights
- 11,625,000 Milestone B rights
