## Share Purchase Plan – How to Download Your Application Form

Stavely Minerals Limited ('Stavely Minerals', ASX Code: SVY) is aware that there may be mail delays for Shareholders who have not elected communication via email receiving their Share Purchase Plan (SPP) Offer Document and personalised Application Form. If you are a Stavely shareholder registered as at 5:00pm (WST) on 4 July 2022 ('Record Date') with a registered address in Australia or New Zealand ('Eligible Shareholder') and would like to participate in the SPP, the Application Forms are available for download via Computershare's Investorcentre website by following the below steps:

- Step1: Being Informed on the SPP offer Click on this link to view the SPP Offer Document
- **Step 2:** Go to <a href="https://www-au.computershare.com/Investor/#Home">https://www-au.computershare.com/Investor/#Home</a> to download your SPP Application Form
- **Step 3:** Click on "Single holding" on the left-hand side of the page with this symbol:



- **Step 4:** Select your Address Location and enter:
  - Your Holder number (including the X or I).
  - Registered postcode or country (if outside Australia).
  - Stavely's ASX code (SVY)
- **Step 5:** Go to 'Documents' at the top of the page.
- **Step 6:** Under 'Statements and Documents' select 'Stavely Minerals Limited' then click to view and download your form titled 'SPP Applications' dated 13 July 2022.
- **Step 7:** If you wish to receive future communication via email, Login in to the InvestorCentre, click on 'My Profile' and select 'Communication Preferences' to enter your email address and update your communication methods.
