	Answer: The Company believes that net operating cash flows will continue at current levels, however, outflows associated with exploration and development expenditure are expected to reduce following the conclusion of the Misima Gold Project DFS during the June quarter and a reduction in the level of spending associated with the Misima ESIA as it is nearing completion.

	Answer: On 7 July 2022, the Company announced it had secured a \$10m debt facility which included Tranche 1 funding of \$5m which was immediately available.
