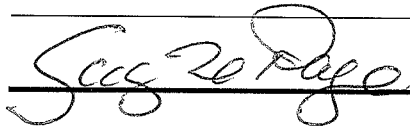

DIRECTIONS

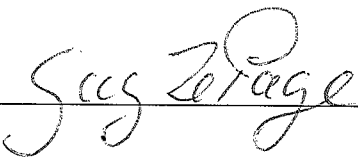
