92 ENERGY TO DRILL 1,500M AT TOWER URANIUM PROJECT

Highlights

- Tower Project Maiden drill program scheduled for September 2022, totalling 1,500m
- Tower Project is located approximately 10km from the world-class Cigar Lake Uranium Mine, which has an average total reserve grade of 15.4% U₃O₈¹

92 Energy's Managing Director, Siobhan Lancaster said:

"Since listing, we have been keen to drill our Tower Project in the heart of the eastern Athabasca Basin uranium district. With minimal historical drilling, we consider Tower to be underexplored and highly prospective for uranium.

"This drill program will be undertaken mid-September 2022, following the completion of our recently expanded Gemini drill program. We look forward to testing more of our exploration models, which to date have proven successful with the discovery of the Gemini Mineralised Zone."

92 Energy Limited (ASX: 92E, OTCQX: NTELF) ("92 Energy" or "the Company") is pleased to provide an update on further planned 2022 exploration activities on its Athabasca Basin, Saskatchewan, uranium properties.

Tower

The Tower Property is located in the eastern Athabasca Basin, approximately 10km east of the world-class Cigar Lake uranium mine. Despite its prospective location, the Tower Property has only been historically tested by four drill holes.




Figure 1: Tower Property with background colour shaded magnetics and prospective drilling areas

A maiden drill program consisting of an initial 1,500m is planned at the Tower Property beginning in mid-September 2022. The drill program will test encouraging geophysical anomalies and interpreted geologic structures generated by 92 Energy's 2021 airborne versatile time domain electromagnetic (VTEM) survey (See ASX announcement dated 3 May 2021), as well as by historical airborne gravity and magnetic surveys. Review the available geophysical data by 92 Energy has resulted in identification of three high priority exploration corridors which range in length between 1 – 10km (Figure 1). Drilling in 2022 be focused within these corridors at areas of interpreted structural significance.
