COMPLETION OF PLACEMENT AND CLEANSING NOTICE

Caravel Minerals Limited (the “Company”) (ASX: CVV) advises that further to its announcement of 3 August 2022, it has now completed the placement of 14,705,883 ordinary shares (“Shares”) at an issue price of \$0.17 per share and has received proceeds of \$2,500,000 (“Placement”).

The remaining \$500,000 of the placement will be issued to Director, Alasdair Cooke, upon obtaining shareholder approval at a general meeting to be convened next month. The Company has also issued 100,000 Shares to a consultant under the Company’s employee share scheme.

 - (B) the rights and liabilities attaching to fully paid ordinary shares.
