### **Golding awarded Mackay Ring Road (Bald Hill Connection) Project**

NRW Holdings Limited (ASX:NWH) is pleased to advise that its wholly owned subsidiary Golding Contractors Pty Ltd (Golding) has been awarded the Mackay Ring Road (Bald Hill Connection) Project by the Queensland Government's Department of Transport and Main Roads.

The contract scope of works includes upgrading approximately a 400m section of the Bruce Highway from 2 lane undivided carriageway to a 4-lane divided carriageway. Major components of the works comprise:

- Widening the existing Bruce Highway to accommodate additional lanes;
- Building new rail overpass over existing rail line;
- Building two new road overpasses;
- Realignment of Bald Hill Road and Bruce Highway Intersection and reconstructing approximately 170m of Bald Hill Road.

The contract is valued at circa \$55 million and construction is scheduled to commence in late October 2022, with an anticipated completion date of May 2024.

NRW CEO & Managing Director Jules Pemberton commenting on the contract said, "Golding has a long history of successfully delivering Department of Transport and Main Roads Projects within Central and Northern Queensland and we are excited to be working with the Department to deliver this critical project in Mackay."
