

# 100% RENEWABLE ENERGY VICTORIA DATA CENTRE SITE FULLY OPERATIONAL

**1 SEPTEMBER 2022:** DC Two Limited (ASX: DC2) ("DC Two" or the "Company"), a vertically integrated revenue generating data centre, cloud and software business, is pleased to announce that its Victoria modular data centre is now fully operational and generating revenue. Initial revenue from the site is expected to be recognised in this July – September quarter, and is estimated to generate A\$1,010,800 per year for DC Two<sup>1</sup>.

DC Two's Victoria data centre is the company's first 100% renewable energy site and is located "behind the meter" at a LMS Energy biogas facility. The data centre draws renewable, low-cost power to decrease operational costs and offers a "green powered" service to Australia customers. The site includes two data centre modules, one owned by DC Two and the other owned by LMS Energy.

The site has initial capacity of 800kw via DC Two's module, with total site capacity expected to increase to 1.2MW as DC Two seeks an agreement to access and sell space in LMS Energy's module<sup>2</sup>. The current contract has sold approximately 763kw of power for DC Two's module, with all customer equipment in the process of being installed and commissioned over the coming weeks. The Company is continuing to work towards selling the remaining capacity to additional customers.

**DC Two Managing Director, Blake Burton said;** "Our Victoria and Mid-West data centres are expected to provide a stable, predictable revenue stream for the Company and are now a proven, first of its kind concept in Australia. These two regional data centres will very shortly be generating almost two times more revenue per year, than the company made in FY21. We expect this revenue growth trajectory to continue as we execute our strategy to become profitable in the future."


