HARVEST WINS TWO-YEAR CONTRACT WITH EUROPEAN DEFENCE FORCE

Highlights:

- **Harvest secures first contract to supply technology to an EU Defence force**
- **The contract will see field deployment of the latest Nodestream Rugged (NSR) devices**
- **Initial contract value is approximately \$60k USD**

September 7, 2022: Harvest Technology Group Limited (ASX:HTG) (**Company, Harvest, Group**) is pleased to announce it has won its first contract with a defence force of the European Union (EU). The contract is for the supply of Harvest's ultra-low-bandwidth, high-quality secure Nodestream™ technology to play a key role in supporting the defence force's remote operations.

The deployment of Harvest's technology into this sector reinforces the credibility of the Nodestream™ technology to other potential customers who need reliable, secure connectivity in remote locations.

The supply of the technology is under Harvest's standard terms with the initial contract value (of approximately \$60k USD) expected to be receipted in October 2022.

Material Terms of Contract

- HTG considers this contract to be material to the extent that it represents the first order from a potentially significant EU defence customer, and a new relationship with the opportunity to expand on this initial contract in the future. Notwithstanding that HTG sees this relationship as a material opportunity, investors should note that it may not result in additional orders beyond this initial order.
- There are no further conditions that need to be satisfied prior to this contract becoming legally binding on the counterparty.
- The counterparty to the contract is a modern middle power sovereign government defence force located in the EU.

The company looks forward to providing further updates on new business opportunities during the current quarter.
