# Jesse#1A Flow Test Update

- Recently drilled Jesse#1A discovery well recorded helium concentrations up to 0.65% and bottom-hole pressures consistent with nearby producing helium fields
- Flow test operations underway at Jesse#1A with initial results expected in the coming week

Grand Gulf Energy Ltd (ASX:GGE, OTCQB:GRGUF) ("Grand Gulf" or the "Company") is pleased to provide an update on maiden potentially company-making helium exploration well Jesse#1A which was drilled by the Company in June 2022.

The successful Jesse#1A discovery well recorded helium concentrations up to 0.65% and a bottomhole pressure of 2,280psi, consistent with regional virgin pressure modelling and initial reservoir pressures at the nearby Doe Canyon Helium Field.

Follow up operations designed to flow test the well are proceeding on schedule, with production flow testing beginning this week following a series of successful downhole data-gathering runs including a full borehole optical log. Initial results are expected as early as next week.

The information gained from the flow tests will be used to further characterise the reservoir and optimise production from Jesse#1A and future Red Helium project wells in a success case. The existing gathering infrastructure and offtake agreement¹ allow for near immediate monetisation of a commercial discovery with minimal time and cost.

The next helium exploration well is planned for Q4 2022.
