CORPORATE GOVERNANCE STATEMENT 2022

1. INTRODUCTION

GreenX Metals Limited (**GreenX** or **Company**) and the entities it controls believe corporate governance is important for the Company in conducting its business activities.

The Board has adopted a suite of charters and key corporate governance documents which articulate the policies and procedures followed by GreenX.

These documents are available in the Corporate Governance section of the Company's website, **www.greenxmetals.com**. These documents are reviewed at least annually to address any changes in governance practices and the law.
