Board Changes at Breaker Resources NL

The Board of Breaker Resources NL ('Breaker') wishes to advise that founder and Managing Director, Tom Sanders, has stepped aside from his role as Managing Director with immediate effect.

The Board intends to recruit a new CEO to drive the group through its future, feasibility, construction and eventually production phases for its advanced Lake Roe Gold Project.

In the interim, the group's Non-executive Chairman, Peter Cook will take on responsibility as acting CEO of the Company whilst it embarks on the transition.

Commenting on the matter, Mr Cook said: "Tom Sanders has done a remarkable job for the shareholders of Breaker. He has discovered a substantial virgin orebody on the doorstep of one of most prolific gold districts in the world. Over the last 6 years he has tirelessly drilled the system out with unwavering passion and commitment.

"The next phase of the Lake Roe development requires a development/production style focus and it is an appropriate time to make that change in the Company.

"Extensive, new high-grade primary structures discovered immediately below the large open pit Resource in the last 18 months has transformed the Company's development options, pointing to a large open pit and underground development that is expected to keep expanding with further drilling.

Tom departs, leaving the Company in fantastic shape. It has ample cash (>\$20million) to fund its ongoing works at Lake Roe, a 20% free carried interest (to positive bankable feasibility) in the growing Manna Lithium deposit and some excellent early-stage exploration prospects in the Avon Valley, east of where the emerging Julimar discovery has set the exploration world alight."

Additional information:

Contractual arrangements relating to cessation of the service contract enabling Tom Sanders service since October 31, 2011 as the Executive Chairman and recently Managing Director will see a full and final payment of \$389,975 (inclusive of GST).

Remuneration payable to Mr Peter Cook during his role as acting CEO will accrue at \$275 per hour. These are chargeable only after the offset of 24hrs per month equating to his expected time input as Non-executive Chairman.

Mr Cook will receive no additional short or long term incentives as part of his interim role, however will continue to receive directors fees of \$72,112 per annum (inclusive of superannuation).
