ISSUE OF SHARES AND APPENDIX 2A

Further to the ASX Announcement on 29 September 2022, Riedel Resources Limited ("**Riedel" or the "Company"**) has issued 260,000,000 fully paid ordinary shares at an offer price of \$0.005 per share (**Tranche 1**). Tranche 1 of the Placement was undertaken pursuant to Listing Rules 7.1 and 7.1A.

Tranche 2 of the Placement (comprising 40,000,000 ordinary shares) is subject to shareholder approval and the annual general meeting is expected to be held on 23 November 2022.
