

## **Issue of Entitlement Offer Options**

Alderan Resources Limited (ASX: AL8) (**Alderan** or the **Company**) advises that it has now issued all options (**New Options**) from the pro-rata non-renounceable entitlement offer (**Entitlement Offer**), as announced in the Prospectus dated 6 September 2022.

The Entitlement Offer was offered on the basis of one (1) New Option for every two (2) Fully Paid Ordinary Shares held by eligible shareholders at an issue price of \$0.001 per New Option. The New Options have an exercise price of \$0.016 with an expiry date of 9 September 2025.
