

## **Drilling Contractor appointed for Copper-Gold Targets in the Paterson Province**

### **Highlights**

- Drilling contractor signed to drill copper-gold targets in South-Telfer / South-Havieron Project area.
- Drilling planned to test VTEM<sup>1</sup> target areas for shallow copper-gold (Cu-Au) mineralisation which may potentially overly deeper, larger Cu-Au systems.




Figure 1: Map of South Telfer Copper-Gold Project showing location of forthcoming drilling areas.

- An initial program of at least 3,000m of aircore drilling will test high-priority target areas along the highly prospective Hasties – Grace Trend (refer to Figure 1).
- Drilling scheduled to commence November 2022.

### **Rincon's Managing Director, Gary Harvey commented:**

*"New discoveries in the Telfer/Havieron area are now being discovered under the Permian top cover and aircore drilling is an essential cost-effective first-pass method to assess the prospectivity of our new gold/copper targets sitting under this cover. This is an opportunity to elevate the first few of the many gold/copper target areas we have identified on our tenements. We're aiming to turn these targets into new prospects that warrant deeper follow-up drilling which could potentially lead to a new greenfields discoveries".*

**Rincon Resources Limited (Rincon or the Company)** is pleased to provide an update on its exploration activities at its South-Telfer / South-Havieron Copper-Gold Project area located in the Paterson Province, Western Australia.

HARMEC Pty Ltd has been appointed preferred contractor to complete the Company's planned aircore drilling activities planned to test multiple VTEM targets across the Company's multiple project areas.

Aircore drilling is a cost-effective first-past test of VTEM targets to detect the presence of copper-gold enrichment in the shallower weathered profile overlying potentially deeper, larger sources of copper-gold mineralisation. The results of the aircore drilling will assist in further assessing the prospectivity and prioritising of the VTEM target areas for potential follow-up RC or diamond drilling if warranted.

An initial program of at least 3,000m of aircore drilling will test three priority targets along the highly prospective Hasties-Grace Trend, a major structural corridor known to host significant copper-gold mineralisation and passes through all the Company's main project areas (refer to Figure 1).

Targets to be tested with the forthcoming program are located along strike and within 5km of Paterson Resources Limited's Grace-Bemm Deposit (Refer to ASX: PSL Announcement dated 10 October 2022) and associated with the same shear/fault zone that controls the copper-gold mineralisation at Grace-Bemm.

Drilling is currently scheduled to commence November 2022.


