## Bulletin Surrounds Aldoro's Niobe Project Mt Farmer Project

## Highlights

- Bulletin continues to receive enquiries regarding Aldoro Resources Limited's Niobe Rubidium-Lithium Project following their maiden resource estimate of 4.6Mt @ 0.17% Rb<sub>2</sub>O and 0.07% Li<sub>2</sub>O (refer ARN announcement dated 12 October 2022)
- Bulletin's Mt Farmer application (E59/2413) is 59km<sup>2</sup>and has along strike potential from Aldoro's 2km<sup>2</sup> Niobe Rubidium-Lithium Project
- Bulletin's Mt Farmer application completely surrounds Aldoro's project
- Bulletin looks forward to updating shareholders once the tenement application is granted
- Bulletin remains well funded and will commence on ground exploration works as soon as possible



Bulletin Resources Limited ("Bulletin", "BNR") is pleased to update shareholders regarding the Mt Farmer tenement application E59/2413 following Aldoro Resources Limited's (ASX: ARN, Aldoro) announcement regarding its maiden resource estimate of 4.6Mt @ 0.17% Rb<sub>2</sub>O and 0.07% Li<sub>2</sub>O at their Niobe Rubidium-Lithium Project (Figure 1) (*refer ASX ARN announcement dated 12 October 2022*).

Following renewed interest and enquiries from shareholders and interested parties, Bulletin confirms the Mt Farmer 59km<sup>2</sup> tenement application E59/2413 completely surrounds Aldoro's 2km<sup>2</sup> P59/2137 which hosts the Niobe Rubidium-Lithium Project. Bulletin's tenement application has over 5km strike of the potential greenstone host to the Rubidium bearing pegmatite unit.

Bulletin originally applied for E59/2413 for its gold and tantalum potential. The tenement application is progressing through the DMIRS tenement grant process.
