Form 604 Correction – West African Resources Limited (WAF)

L1 Capital Pty Ltd (ABN 21 125 378 145) (**L1 Capital**) notes that the filing of the “notice of change of interests of a substantial holder” form (**Form 604**) for WAF lodged with the Australian Securities Exchange (**ASX**) and WAF on 21 June 2021 was incomplete.

The Form 604 was incomplete in that it inadvertently omitted the relevant consideration amount of \$10,177,976.00 having been paid to L1 Capital for the sale of 10,706,506 securities.

An amended Form 604 is attached to this letter, which has been lodged for the sole purpose of correcting the previous Form 604.

A copy of the amended Form 604 has also been lodged with WAF.

For completeness, L1 Capital notes that it lodged a “notice of ceasing to be a substantial holder” (**Form 605**) on 23 February 2022.

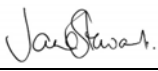
