QUARTERLY REPORT TO 30 SEPTEMBER 2022

HIGHLIGHTS

- Updated Prefeasibility study on HTLO completed.
- Primary approval moves a step closer with EPA draft report near completion.

Audalia Resources Limited (ASX: ACP) is pleased to present its report for the September 2022 quarter.

MEDCALF PROJECT

The Medcalf Project is a vanadium-titanium-iron project located some 470 kilometres south east of Perth near Lake Johnston, Western Australia. The Medcalf Project comprises of one granted exploration licence E63/1855, two miscellaneous licences L63/75 and L63/94 and two General Purpose licences G63/10 and G63/12 as well as mining lease M63/656. Together these licences cover a total area of 38 km².

The Medcalf Project lies in the southern end of the Archaean Lake Johnston greenstone belt. This greenstone belt is a narrow, northnorthwest trending belt approximately 110 km in length. It is located near the south margin of the Yilgarn Craton, midway between the southern ends of the Norseman-Wiluna and the Forrestania-Southern Cross greenstone belts.




Figure 1: Medcalf Project - Location Map



Updated Prefeasibility Study (PFS)

During the quarter, an updated Pre-Feasibility Study (PFS) on its 100%-owned Medcalf Project, was completed by METS Engineering (METS). Refer to ASX announcement on 26 July 2022 for full details.

The PFS includes an economic valuation and supports the potential for high grade titanium lump ore (HTLO) product Western Australia-based mining and processing operation suitable for the blast furnace steel mills in Asia as a hearth liner for protection of the furnace walls.

The study has been completed to a PFS-level of accuracy and all costings, unless specified otherwise, have been undertaken at an accuracy level of ± 25 %.

Key PFS highlights

- The Medcalf Project scope has been revised to significantly reduce the upfront capital cost, simplify and de-risk the project;
- The Project produces high TiO₂ lump ore (HTLO) for refractory lining protection in blast furnace applications;
- Highly favourable economics, NPV (8%) AUD\$178M, 146% IRR and a 0.7 year payback (using the projected long-term price from local market research); and
- A number of options have been identified to further improve the economic outcomes of the Project including extended the life-of-mine with inclusion of the inferred resource and possible value addition through sale of the fines product.

Environmental permitting update

The Environmental Protection Agency (EPA) have advised the Company that their draft report is near completion for the EPA Board to consider for primary approval. The Company has been in a number of discussions with the EPA on finalising the conditions of their report.

The Project is currently compliant with environmental, legal and permitting requirements.

CORPORATE MATTERS

The Company had cash and cash equivalents as at 30 September 2022 of \$75,000 (Q4 FY22: \$201,000) following payments for capitalised exploration and evaluation expenditure of \$269,000 (Q4 FY22: \$22,000) and payments to related parties and their associates of \$35,000 (Q4 FY22: \$76,000) during the September 2022 quarter.

On 1 August 2022, the Company appointed Mr Adam Buckler as a non-executive director of the Company.

After the end of the September 2022 quarter, the Company negotiated access to an additional loan facility of up to \$500,000 from a director, Siew Swan Ong, to meet its working capital requirements (**Additional Related Party Loan Facility**). The Additional Related Party Loan Facility is unsecured, provided on 5% interest per annum, accruing on daily basis and payable on the repayment date of 31 January 2024, which may be extended on the same terms by mutual agreement. Full details of the Additional Related Party Loan Facility are set out in the ASX release dated 26 October 2022.

The Company acknowledges its cash position at the end of the quarter and its estimated cash available for future operating activities. The Directors continue to assess funding alternatives to ensure the Company can continue exploration and evaluation activities at the Medcalf Project.

A \$2million loan attract an 8% interest rate per annum (compounded daily) and the drawn down amount is payable in full (with accrued interest) on 21 November 2022. The amount is unsecured. On 10 March 2022, the Company announced that it has negotiated the extension of the repayment date to 31 January 2024.

A \$1million loan attracts an 10% interest rate per annum (compounded daily) and the amount is payable in full (with accrued interest) on 20 November 2022. The loan is unsecured. On 10 March 2022, the Company announced that it has negotiated the extension of the repayment date to 31 January 2024.

The Company has access to a total loan facility of up to \$1million from a director, Siew Swan Ong, to meet its working capital requirements (**Related Party Loan Facility**). The Related Party Loan Facility is unsecured, provided on interest free and fee-free terms and has a repayment date of 30 June 2022, which may be extended on the same terms by mutual agreement. On 30 June 2021, the Company announced that it has negotiated the extension of the repayment date to 31 January 2023. Full details of the Related Party Loan Facility are set out in the ASX release dated 16 June 2020 and 28 September 2020.

On 29 October 2021, the Company negotiated access to an additional loan facility of up to \$1million with 5% interest rate per annum (compounded daily) from a director, Siew Swan Ong, to meet its working capital requirements (**Additional Related Party Loan Facility**). The Additional Related Party Loan Facility is unsecured, and the amount is payable in full (with accrued interest) on 31 January 2023. Full details of the Additional Related Party Loan Facility are set out in the ASX release dated 29 October 2021.

Answer: Audalia is in the exploration and evaluation phase of its flagship Medcalf Project and as a result, expects to have negative operating cash flows for the time being.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Audalia manages its cash flow through ongoing budgeting, forecasting and financial reporting processes, using that information to make decisions about the Company's activities and to determine the form and timing of funding for those activities. Audalia has been able to demonstrate a record of securing funds when required (refer to ASX announcements dated 30 November 2020 - Completion of Placement of \$400,000, 28 September 2020 and 16 June 2020 - Funding Update, 6 March 2020 - Completion of Placement of \$360,000, 11 July 2019 – Update on funding and capital raising, 20 June 2018 – Shortfall on entitlement issue and 16 March 2018 – Update on Funding) and is confident that it will be able to continue to do so.

Answer: The Company expects to continue its operations and to meet its business objectives as it is confident that it will be able to continue to raise funds as and when required.
