The company does not believe it will have the current level of net operating cash flows. Included in outgoings 1.2 b) is inventory in the lead up to the seasonally busy period over December 2022 and March 2023 quarters. Inventory outgoings is expected to be significantly reduced in the next quarter.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Yes, In October 2023 National Australia Bank conditionally approved a \$1.2m Finance Facility.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Yes, the company expects to be able to continue its operations and to meet business expectations. This will be achieved due to the seasonally busy period over the next 6 months, when inventory purchases will be returned to cash over the next two quarters. NAB finance facility will assist with future inventory purchases.
