8.8.1	Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
	Answer: No the Company undertook a significant drilling program Paterson Central during the quarter. While the Paterson program continued into Q2 – expenditure is significantly less and drilling is expected to finish in early November. Limited on ground exploration work is expected in the Quarter due to the need to receive and review drill data, the onset of the cyclone season in the Pilbara region and the summer holiday shut down.	

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company has investments in listed Company assets in the amount of \$~4.8m of which ~A\$1.8m is freely tradable and a further A\$1.8m becomes freely tradable in March 2023 and the remainder in early 2024. The company will consider capital raising initiatives in addition to potential sale of these investments, as required.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: The Company announced a significant increase in the Carlow Castle mineral resource post-period. Yes, the Company will be able to continue operations on the basis of funds on hand, a seasonally imposed significant reduction in exploration activity and a potential to sell down of some or all of its freely tradable investments, and raise additional capital.
