RINCON 2,000TPA Li_2CO_3 OPERATIONAL UPDATE

HIGHLIGHTS

- **98% of 2,000tpa operational development works complete - with plant commissioning 86% complete**
- **Current commissioning and production test-works producing primary lithium product toward battery quality lithium carbonate production**
- **Continuous lithium carbonate production operations scheduled during next quarter**

Argosy Minerals Limited (ASX: **AGY**) ("**Argosy**" or "**Company**") is pleased to advise further progress at the Rincon Lithium Project, located in Salta Province, Argentina, with 98% of the total works now completed for the development of the 2,000tpa lithium carbonate production operation.

The Company is progressing commissioning and production test-works to produce battery quality lithium carbonate product. Current plant commissioning works have successfully produced primary lithium product, which is being processed through multiple stages to produce battery quality lithium carbonate product.

The 2,000tpa production operation major works comprise three main phases - being design, construction and commissioning.

- The design phase works are completed (100%);
- The construction phase works are 99% complete; and
- Plant commissioning works are 86% complete.

The construction phase comprises the process plant, equipment and associated installations, earthworks and site facilities (including additional camp development and associated site infrastructure), and expansion of the brine system (pumping station, plant settling ponds), with all construction works at effective practical completion;

- › earthworks/land movements completed (100%);
- › site works completed (100%) (comprising site camp/accommodation, laboratory, office, and other works);
- › brine system works completed (100%) (comprising pumping station and plant settling ponds works);
- › 99% of the process plant completed (comprising plant equipment acquisition, installation and plant warehouse works); and
- › 96% of utilities and associated services (comprising vapour system, communication system and ancillary services works).

The overall commissioning phase works have advanced toward full integration of plant and systems commissioning, producing primary lithium product, and preparing for production of battery quality lithium carbonate, with;

- › 93% raw materials procurement/acquisition achieved;
- › 95% operations personnel recruitment and development conducted; and
- › 82% plant and equipment commissioning tests performed.

Argosy Managing Director, Jerko Zuvela said ***"The Company's 2,000tpa operational development works are culminating towards realising continuous lithium carbonate production operations. The Puna operations team have worked exceptionally toward achieving this major milestone."***

The Company is very excited as we progress to become the 2nd ASX listed commercial scale lithium carbonate production company, transforming into a cashflow generator and leading to a significant near-term growth phase for the Company.

The lithium market maintains its strong momentum with lithium carbonate prices forecast to continue around record highs into 2023 and beyond, resulting in very lucrative upcoming product sales revenues."

The Company is progressing toward producing battery quality lithium carbonate product during full systems commissioning works, whilst continuing final commissioning and production test-works toward commercial scale operations, and ramp-up toward continuous production operations during the next quarter.

The Company's aim is to ensure the final phase commissioning works are successfully completed to establish efficient steady-state production operations for the longer term. The Company is not compromising on the quality of any final works to achieve 100% effective production operations to become a successful commercial battery quality lithium carbonate producer.

The current 2,000tpa production target is intended to form a modular part of the 10,000tpa operation from its commencement.
