HIGHLIGHTS

- Initial field geological mapping at Poona West and Poona East lithium targets completed (refer ASX release dated 20 October 2022)
- Follow-up mapping and sampling commenced in October
- High resolution airborne photographic survey commissioned covering Poona Lithium Corridor – completed during October
- Further evaluation of existing imagery, historic sampling and geochemical results
- Detailed drill planning of PGE-Ni-Cu targets completed at Pallas and Perses in preparation for commencement of initial RC drill testing
- Detailed drill planning for Poona West and Poona East currently being refined following field mapping completion
- Planning completed for additional Heritage Survey clearances following field reconnaissance
- Near-term exploration to include geological mapping, soil geochemistry, RC drilling of lithium and PGE-Ni-Cu targets, airborne and/or ground EM survey

Scorpion Minerals Limited (ASX:SCN) (**Scorpion, SCN or the Company**) is pleased to present its Quarterly Activities Report for the period ending 30 September 2022.

Exploration & Development Portfolio Summary

Pharos Project, WA (SCN:100%)

The Pharos Project is 100% owned by Scorpion and covers an area of 1,544km² located 60km northwest of Cue in the Murchison Mineral Field, Western Australia.

During the quarter a number of activities were completed that continued to build on the Company's knowledge of the project area, resulting in the identification of multiple targets for further field work.

Lithium Targets

Poona West And Poona East Initial Field Reconnaissance Completed

Scorpion has confirmed that a 50km strike zone of significant rare metal and Lithium, Caesium, Tantalum ("LCT") pegmatite potential exists within the Company's Pharos Project.

The interpreted LCT Pegmatite Emplacement Zone ('PEZ') extends from West of the Poona Prospect to the Jacksons Reward Prospect area within the greater Pharos project area (Figure 2). Field reconnaissance was completed during the quarter with initial mapping focused on previously identified LCT pegmatites that have been inadequately drill tested at the Poona West and Poona East prospect areas.

High resolution (15cm) airborne ortho photographic survey was commissioned (completed October) over the Poona project area to further aid in accurate mapping, sampling and drill planning. Further geological mapping was completed during October and initial RC drill testing at Poona West and East will be completed during the December quarter once Native Title Party heritage monitors become available.

Base Metal Targets

The Pharos Project contains the Pallas, Mughal and Perses PGE-Ni-Cu-Co targets plus the Mt Mulcahy Cu-Zn-Ag-Au VMS deposit. Detailed RC drill hole planning has been completed for initial drill testing of Pallas and Perses, the planning has been further modified to take into account recent discoveries in the Eastern Goldfields (e.g. Galileo Mining's Norseman project). RC drill testing of these targets will be completed simultaneously with RC drilling at the nearby Poona lithium targets.

Gold Targets

Follow-up RC and/or diamond drilling is proposed for the existing gold targets at Oliver's Patch and Ulysses once RC programmes are completed at lithium and PGE-Ni-Cu targets.

Scorpion Metals Limited (ASX:SCN) is an Australian mineral exploration and resource development company with a focus on creating wealth for shareholders through the discovery of world-class deposits, over a diversified range of minerals. Our current efforts are centred on our Pharos Project, located in the Murchison Province of Western Australia.

The Pharos Project

The Pharos Project consists of 1,544 square kilometres of granted tenure, located northwest of the small mining town of Cue (approximately 50 km) in the Murchison Mineral Field. The project is easily accessible from the Great Northern Highway by the sealed Jack Hills Mine access road and then by unsealed tracks. Scorpion holds a 100% interest in the project.

The project is prospective for lithium, PGE-Ni-Cu, gold, iron ore and VMS hosted Cu-Zn-Ag-Au mineralisation, and contains the Mt Mulcahy deposit. The 'South Limb Pod' zone of mineralisation at Mt Mulcahy contains a JORC 2012 Measured, Indicated and Inferred Resource of 647,000 tonnes @ 2.4% copper, 1.8% zinc, 0.1% cobalt, 20g/t Ag and 0.2g/t Au.

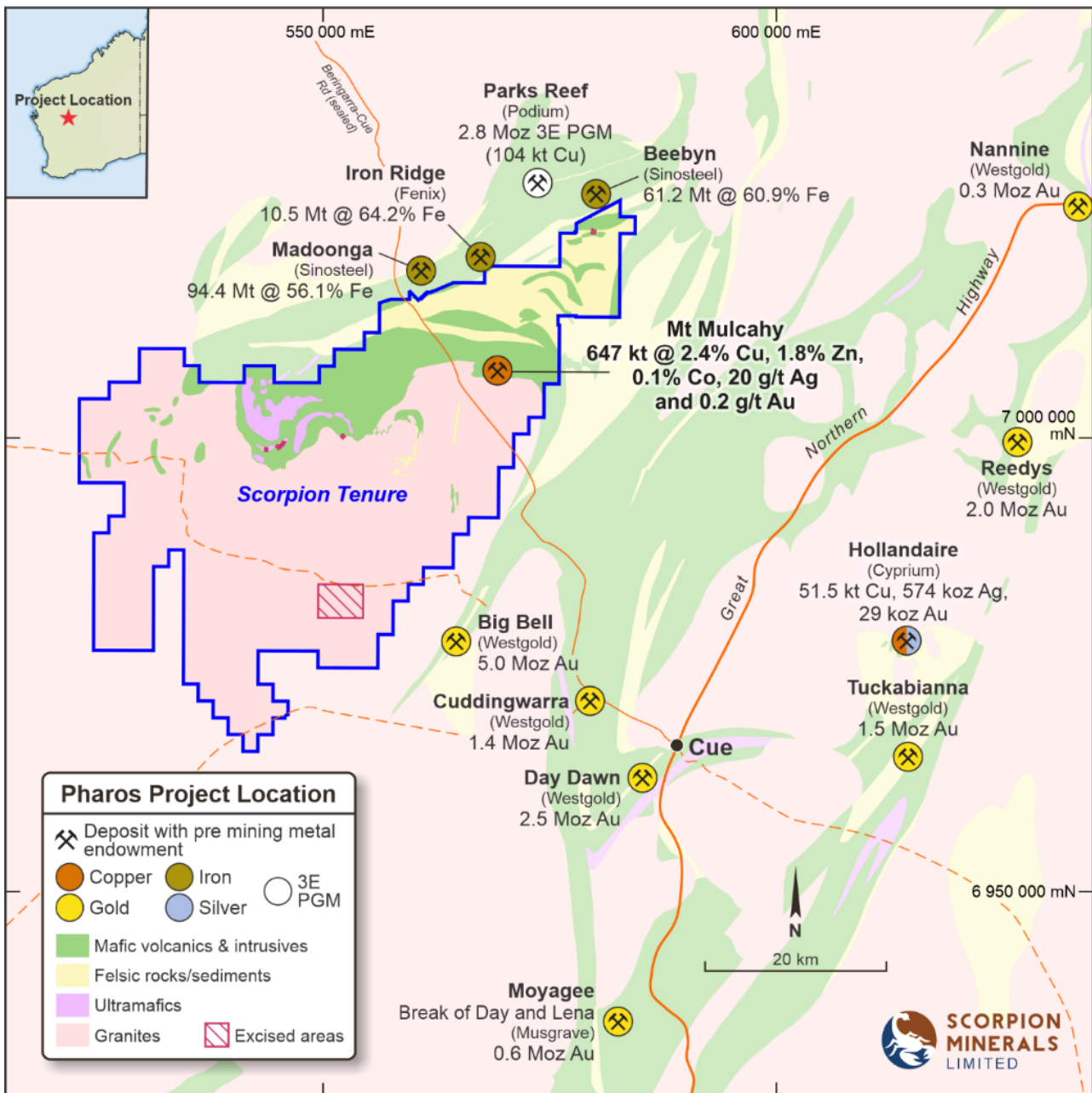


Figure 1: Location of Scorpion Minerals Pharos Project and Regional Resources

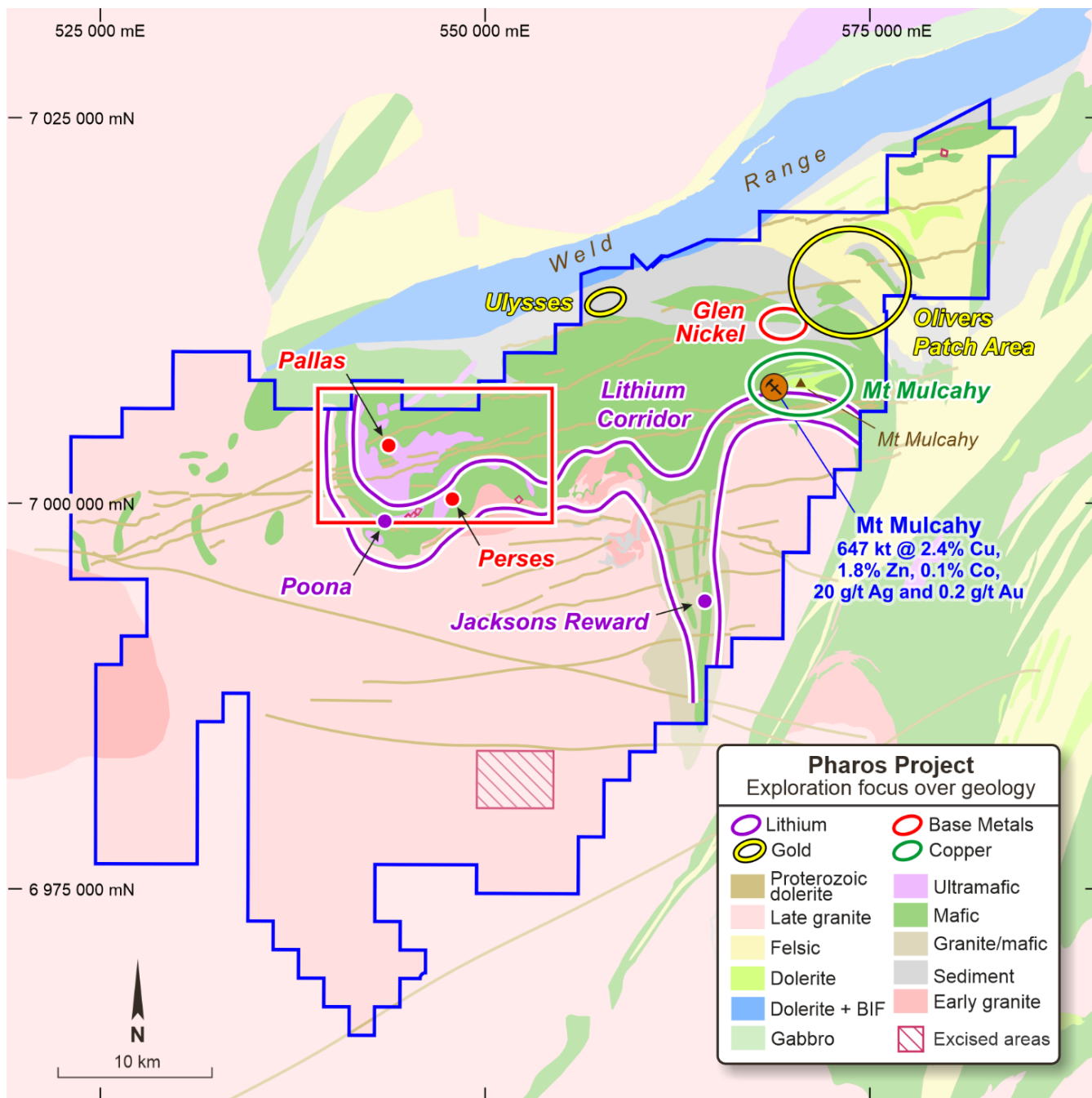


Figure 2: Location of Pharos Commodity Targets Mt Mulcahy Cu-Zn-Ag-Au Resource
