## **CLEANSING STATEMENT**

Dreadnought Resources Limited ("**Dreadnought**" or "the Company") advises that a total of 10,178,000 ordinary fully paid shares were issued 31 October 2022 on the early exercise of options and, the issue of shares to the vendors for the tenement acquisitions announced on 26 October 2022. A breakdown of the share issues is provided below.

## **Early Exercise of Options**

- 900,000 exercisable at any time until 2 July 2024 at an exercise price of \$0.04 per option
- 750,000 exercisable at any time until 31 October 2023 at an exercise price of \$0.02 per option
- 2,750,000 exercisable at any time until 1 October 2023 at an exercise price of \$0.01 per option

## **Issue of Shares to Vendors**

- 2,778,000 at a deemed issue price of \$0.089
- 3,000,000 at a deemed issue price of \$0.115

The amount raised on the exercise of the options was \$78,500.

The Company relies on section 708A of the Corporations Act 2001 (Cth) (the Act) in relation to the Issue.
