Shares will be issued in two (2) tranches, the first tranche expected to settle on Friday 28 October 2022 being 37,457,777 shares and the second tranche expected to settle on Wednesday 30 November 2022 being 19,120,000 shares. The Company has also granted an option to subscribe for a further \$R30m (~A\$2.6m) at a price that is the greater of the 14 days VWAP of the Company's shares at the time the option is exercised or \$0.09. The option expires on 28 February 2023. Using AUD 2,600,000 and the issue price of \$0.09, the maximum share issue on exercising of the option would be 28.888.889.
