

NEXION Quarterly Update, Q2 FY23

NEXION continues to deliver sales growth from the outset of Q2.

NEXION Group Ltd (ASX: NNG) (**NEXION**), the fast emerging, global Hybrid Cloud service provider, is pleased to advise it has delivered a record sales result in October, following on from a record revenue result in Q1.

Highlights

- At the end of Q1, NEXION announced it had delivered its 6th consecutive quarter of growth and the highest quarterly revenue in the Company's history.
- This trend continued in Q2 with the company having raised invoices and received purchase orders representing \$1.1m in October 2022.
- The acquisition of new brand-name enterprise customers drove this outstanding result that should all be booked to revenue in November and reported in full for Q2.
- Overall, NEXION continues to experience strong demand for all core services across Australia and New Zealand, especially in cyber security.

NEXION continues to grow rapidly, adding new enterprise customers on an ongoing basis. The addition of new national multi-site enterprise names to NEXION's customer stable is pleasing. NEXION continues to see customers invest in technology upgrades, especially for network security using products supplied and supported by NEXION. NEXION's uniqueness in its ability to offer the full suite of technology services as well as onsite remote testing and provisioning, has seen global enterprises turn to NEXION for new systems and services in this quarter. NEXION is experiencing significant demand in security, cloud, networking, and satellite and so our valuable underlying recurring revenue continues to build.


Group CEO Paul Glass said:
