## **Results of Annual General Meeting**

Pursuant to ASX Listing Rule 3.13.2, the Company advises that, other than Resolution 5, the resolutions contained in the Notice of Meeting dated 14 October 2022 and considered at today's Annual General Meeting of shareholders were all passed on a poll of shareholder votes.

In accordance with ASX Listing Rule 3.13.2 and Section 251AA of the Corporations Act, the details of the votes cast on each of the resolutions and the proxies received in respect of each resolution are set out in the table on the following page.

The Company advises that Resolutions 3 and 6, both being special resolutions, required approval from 75% of all votes cast and were passed by a sufficient majority.

Special Resolution 5, in relation to a proposed amendment to the Company's Constitution to permit the use of technology at general meetings to the extent permitted under the Corporations Act, Listing Rules and applicable law, did not receive approval from at least 75% of all votes cast. The Company intends to continue to hold its general meetings in person and this resolution merely provided flexibility if restricted from doing so by Government directions. Accordingly, the outcome on Resolution 5 is unlikely to have any adverse impact on the Company.
