

RESIGNATION OF NON-EXECUTIVE DIRECTOR

Hot Chili Limited (ASX:HCH) (TSXV:HCH) (OTCQX:HHLKF) ("Hot Chili" or the "Company") announces the resignation of Dr Allan Trench as director of the Company effective 30 November 2022.

Dr Trench has given notice of his resignation as a director effective today. He will also retire from his positions as Chair of the Audit & Risk Committee and member of the Remuneration, ESG and Nomination Committees. Dr Trench has been an invaluable member of the Hot Chili Board since July 2010, following the listing of the Company on the ASX in May 2010, and has made a considerable contribution to the transformation of Hot Chili to a copper developer.

The Company would like to thank Dr Trench for his twelve years of service to Hot Chili and wishes him all the best in his current and future endeavours.

Non-executive Chairman Dr Nicole Adshead-Bell commented "We would like to express our thanks and appreciation to Allan for his service to the Company. He contributed a wealth of experience, insight and knowledge to the Company. On behalf of the Board of Directors, management team and our shareholders I thank him and wish him every success."

As noted in ASX announcement dated 29 November 2022, recent board changes provide the Company with an opportunity for Board renewal and Hot Chili will seek to identify and appoint a replacement independent director to ensure the Board has the appropriate levels of skills and experience, suitable for the Company as it pursues its long term growth strategy and the development of the large scale Costa Fuego Project
