SECTION 708A NOTICE – ISSUE OF SHARES

Sunshine Gold Limited (ASX:SHN, “Sunshine Gold”, “the Company”) provides this notice to ASX under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) in relation to the issue of 9,800,000 fully paid ordinary shares at \$0.025 per share (**Shares**) in the capital of the Company pursuant to a share placement to directors of the Company without disclosure under Part 6D.2 of the Corporations Act.
