# Hannans Ltd – (ASX: HNR) – Anticipated Reinstatement to Quotation

#### **Description**

It is anticipated that the securities of Hannans Ltd ('HNR') will be reinstated to quotation at 10.04:30am (+/- 15 seconds) AEDT on Friday, 9 December 2022, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

HNR raised \$2,000,000 pursuant to the offer under its prospectus dated 17 October 2022 and supplementary prospectus dated 8 November 2022 by the issue of 100,000,000 shares at an issue price of \$0.02 per share.
