RECEIPT OF DEFAULT NOTICE

Mineral Commodities Ltd (ASX: MRC) (**Company**) advises that it has received a notice of default (**Default Notice**) from minority ~10% shareholder BSG Mining LLC (**BSG**) in relation to the shareholders deed between MRC Graphite (Norway) Pty Ltd (a subsidiary of the Company) (**MRCGN**), BSG and Skaland Graphite AS entered into on 13 February 2020 (**Shareholders Deed**).

The Company is currently reviewing the Default Notice and is seeking external advice. While MRCGN and the Company do not acknowledge any breach of the Shareholders Deed, the Company continues to be in discussions with BSG regarding the Default Notice and the process to rectify any alleged breaches.

The Company will continue to keep the market updated with further information as it becomes available.

In April 2022, the Company released its Five-Year Strategic Plan 2022-2026¹ to delineate and implement its aspiration to become a leading vertically integrated diversified producer of graphitic anode materials and value added mineral products with a commitment to operate with a focus on the Environment, Sustainability and Governance.
