

# Darling Range Application Update ELA 70/5111

## Prospective for PGE Ni Cu Co



Western Yilgarn's Darling Range project remains "under application" at the time of publishing this update. The project is one of many that have been stalled by Government process whilst it awaits guidance from the Minister and at Department of Mines, Industry Regulation and Safety (**DMIRS**).

#### **DMIRS** position:

#### DMIRS has advised that

- it is considering the implications of the recent Supreme Court Blue-Ribbon decision, which relates to the grant of tenements subject to "no mining" conditions.
- it is currently developing a policy regarding the use of no mining conditions and expects the policy to be out for industry comment shortly and to have the approved policy in place by Q1 2023.



### Western Yilgarn summary:

- Western Yilgarn has been assured it application is in good standing and has advised the market of this in previous communications.
- Based on DMIRS advice, it is not unreasonable to expect granting of E 70/5111 in Q1 of 2023, or shortly thereafter.
- Western Yilgarn continues to be encouraged by the ongoing successful exploration efforts being reported by its adjoining neighbour Chalice Mining (ASX CHN). Western Yilgarn encourages the reader to analyse the exploration results to date on Chalice' "Gonneville" project. This project resides less than 2500metres from the Western Yilgarn/Chalice tenement border.

Western Yilgarn invites the reader to view a video relevant to its ELA 70/5111 application. The video provides some context to why Western Yilgarn looks forward to exploring the lease.
