

TBB UPDATE

Wellfully Limited (ASX: WFL) (Wellfully, or the Company) would like to inform that The Brandbase (TBB) companies have entered into recent voluntary and temporary administration.

This means that the proposed transaction (refer ASX announcement of 6 December 2022) is still possible until the end-of-January 2023, by taking TBB out of voluntary administration and proceeding along the lines of the announced Memorandum of Understanding. This opens new opportunities for the Company in possibly seeking a more efficient outcome through the administrator, one that could allow for a more favorable balance sheet in terms of liabilities settled with creditors through the administrator.

In synthesis and as such, the approvals sought can be expected to be within the maximum proposal parameters, where the Company will seek to arrive to an equivalent, or more favorable outcome.

This was licensed and commercialized in 2014.

The second magnetic technology, the Programmable Array technology, employs powered electromagnetic fields that can be altered to suit individual consumer's skincare needs. This was licensed for skincare applications in 2020.
