- 1. VBS Exchange has transferred 26,190,476 shares in Altamin Limited ACN 078 510 988 (**Altamin**), (**Interest Securities**), to its sole shareholder, VBS Investments.
- 2. VBS Investments proposes to transfer the Interest Securities to Gannet in exchange for units in the Victor Smorgon Partners Global Multi-Strategy Fund (**Fund**) (**Transfer**).
- 3. VS Partners is the Fund's manager and provides investment management services to the Fund in accordance with the Investment Management Agreement between VS Partners and Gannet dated 23 June 2022.
- 4. On completion of the Transfer:
 - (a) Gannet will have acquired the Interest Securities;

 - (c) VBS Exchange will continue to hold 127,096,552 shares in Altamin.
- 5. As a result of the Transfer and arrangements within the Fund, the parties enter into this document to record their common intention from the date of this document to work collaboratively in respect of their shares in Altamin.
- 6. Each party acknowledges that this document results in them becoming associates for the purposes of the *Corporations Act 2001* (Cth) and they or their relevant affiliates will be required to lodge an updated substantial holder notice to Altamin and ASX.
- 7. For the avoidance of doubt, nothing in this document is intended to give either party (or its respective affiliated entities) any relevant interest in Altamin shares in which the other party (or its affiliated entities) has a relevant interest. Accordingly, this document does not restrict in any way a party or its affiliated entities from exercising voting rights attached to Altamin shares or disposing of any interest in any such shares.
