The Company is continuing to review and consider projects and business acquisition opportunities, which may not be in the technology sector, whilst reducing operational spend.

There were no substantive business activities undertaken during the quarter.

CorporateFinancial Snapshot

The Company’s net cashflow outflows from operations for the quarter was \$30,000 consisting of administration and corporate costs of \$27,000 and rental expense of \$3,000.
