The interest rate on drawn funds is 12% p.a. and a penalty interest rate of 20% on drawn funds applies in circumstances where the Company is in default. The debt facility is unsecured. The lenders are Conidico Superannuation Pty Ltd (up to \$100,000) and Saki Partners (Services) Pty Ltd (up to \$50,000).
