RBR Group secures 2nd camp contract at Temane

- RBR Group Limited (**RBR** or **Company**) operating entity Projectos Dinamicos (**PD**) awarded preferred contractor status on a 2nd camp facility contract in Temane, Mozambique.
- Contract value of circa **US\$5.0m** is for the supply and construction of 420-person camp and site work facilities at the Temane 450MW Gas Power Plant Project.
- Contract completion & handover scheduled for July 2023.

PD appointed as subcontractor to RADX/TSK as Engineering, Procurement, Construction & Management (EPCM) contractor.

PD has been appointed as contractor on a circa **US\$5.0m** contract for the supply and construction of camp accommodation and associated infrastructure facilities for the 450MW Gas Power Plant Project in Temane, Mozambique. PD will engage as a subcontractor to RADX/TSK. TSK is a Spanish based multinational organisation which has been appointed as a contractor to CTT, Central Térmica de Temane, the project entity formed by the consortium of Sasol, Globetech and EDM, the Project co-developers.

The PSA development is an integrated oil and LPG project being developed by Sasol Petroleum Mozambique in Temane which will supply gas to a 450-megawatt gas-fired power plant at the Central Térmica de Temane LPG facility in the same time frame. The balance of the gas produced will be exported to South Africa to sustain Sasol's operations.

PD is responsible for the Design, Supply & Installation of accommodation and additional temporary site facilities for TSK staff and contractors as part of the growing workforce that will be constructing the CTT Project.

Whilst additional contract terms are being finalised discussions continue in relation to a possible further engagement for ongoing facilities management post construction with revenues based on a US\$ per person/ per day rate. PD is investigating bespoke camp management systems for this development.

RBR Executive Chairman Ian Macpherson said:

“As outlined in our release of 20 September we were confident that our early mover approach to establishing a presence in Temane would lead to further opportunities for engagement in this significant energy project.

This 2nd contract clearly confirms that we are now committed to two valuable service contracts with quality international partners at Temane. In addition, construction on our 100% owned Shankara Lodge camp and training facility is underway and discussions are advanced with several parties as to utilising that facility”.
